

MINUTES  
PARK COMMISSION  
MEETING OF THURSDAY, MAY 22ND, 2015

The Park Commission held a meeting at 6:00 p.m. on Friday, May 22nd, 2015 at their office located at 45 Meadow Lane, Brockton, MA. There being a proper quorum, the meeting was called to order by Chairman Harold Marrow. Present were Commissioners Chickie Studenski, Bill Keane, Chris Connolly, Billy Anderson and Superintendent Timothy W. Carpenter.

  - Saturday – 4:00 PM to Dark


North Junior/Middle School:
