The Standing Committee on Finance met on the following dates – June 6, 7 and 8, 2016 at 6:30 P.M. in the Council Chamber, City Hall with Councilor President Cruise presiding. All Councilors were present on June 6 except Councilor Barnes. All Councilors were present on June 7 except Councilor Monahan. All Councilors were present on June 8.

On June 8, 2016 the Standing Committee on Finance on a motion by Councilor Sullivan and seconded by Councilor Asack, the Standing Committee recommended the following budget reduction:
