4. Hearing on the request from Fernando Huaman dba Pollos a la Brasa Luchito for a Common Victualer license at 74 West Elm Street.
5. Hearing on the request from Mayra Sosa dba El Mariachi for a Common Victualer license at 1753 Main Street.
6. Hearing on the request from Philip Reid dba Reggae on the Grill for a Common Victualer license at 25 Pleasant Street.
7. Hearing on the request from Dana Nessen dba Avon Auto Brokers 4, holder of a Class II Used Car Dealer license at 1115 North Montello Street, to amend the stipulation on the license by increasing the number of vehicles allowed from 46 to 62.
8. Hearing on the request from Max Pacheco dba Buena Vista Restaurant, holder of a wine and malt restaurant license at 526A Main Street, to hold a community event in the parking lot of the restaurant on Saturday, June 19, 2010, from 12:00 noon to 5:00 p.m.

9. Hearing on the request from Bunratty's, Inc. dba T.K. O'Shea's – Peter P. Moynihan, Manager, 347 North Pearl Street, to transfer the license to MPJ Associates, Inc. dba Mickey Malones.

MPJ Associates, Inc. request the following:

- (a) To appoint Peter P. Moynihan as the manager;
 - (b) A 2:00 a.m. closing hour on Thursdays, Fridays, Saturdays and eves of legal holidays;
 - (c) An Entertainment license for Disc Jockey and Karaoke, televisions and radios on Sunday from 12:00 noon to 11:00 p.m., on Monday through Wednesday from 11:00 a.m. to 1:00 a.m. and on Thursdays through Sundays from 11:00 a.m. to 2:00 a.m.
10. Hearing (postponed from meeting of April 15, 2010) on the charges brought by the local police against Consanguinity, Inc. dba The Tekoah – Shear Yashub I. Shear Yashub, Manager, 34 Petronelli Way, of the following alleged violations:
- (a) **Brockton License Commission Rule #8 (3counts)**, to wit: “The last drink must be served before the closing hour. All glasses and bottles must be cleared from the tables or bar by 15 minutes after the closing hour. All customers must have left the premises by 30 minutes after the closing hour. Any licensee and his employees shall not be prohibited from being upon such premises at any time for the purpose of cleaning, making emergency repairs to, or providing security for, such premises or preparing food for the day's business or opening or closing the business in an orderly manner. They may not drink after the closing hour.”, observed on March 21, 2010 at 1:45 a.m., on March 27, 2010 at 1:41 a.m., and on April 25, 2010 at 1:20 a.m.
 - (b) **Allowing unauthorized entertainment in the form of a Disc Jockey and permitting entertainment beyond the hours approved.** (Currently licensed for Orch (7) pieces, Vocalists, Dancing by Patrons on Mon. thru Sat. - 11 a.m. to 12:30 a.m. and Sun. - 12 noon to 12:30 a.m.)
11. Hearing on the charges brought by the local police against Soares Club LLC dba Bar Dino's – Lucindo Soares, Manager, 1002 Main Street, of the following alleged violations:

- (a) **M.G.L. Chapter 138, Section 34**, to wit: “. . . whoever makes a sale or delivery of any such beverages to any person under twenty-one years of age, either for his or her own use”, on April 2-3, 2010.
 - (b) **M.G.L. Chapter 138, Section 23**, to wit: “No license issued under section twelve fourteen or fifteen...shall authorize the sale of any alcoholic beverages other than those purchased from a licensee under section 18, 19, 19F or 19C...”, on May 13, 2010 at approximately 1:56 p.m.
